

Choice of home member state in accordance with Directive 2004/109/EC

ČEZ, a. s., as an issuer of notes admitted to trading on the regulated market of the Luxembourg Stock Exchange, notifies in accordance with Article 2 par. 1 point (i) item (ii) of the Directive 2004/109/EC of the European Parliament and the Council, as amended, and Section 123(1) of the Czech Act No. 256/2004 Coll., on conducting business on the capital market, as amended, the election of the Czech Republic as the home member state with respect to:
