- b) I am not an employee of the Company or a related company and have not been an employee in the previous three years⁴;
- c) I do not receive, and have not previously received, significant additional remuneration from the Company or a related company, other than remuneration for acting as a non-executive member of an elected body. Significant additional remuneration means, in particular, participation in the Company's share option scheme or any other remuneration scheme related to the performance of the office; this excludes the receipt of fixed amounts under a pension plan (including deferred remuneration) for past service to the Company (provided that such remuneration is in no way conditional on continued service to the Company);
- d) I am not a majority shareholder of the Company, nor do I represent it in any way⁵;

- f) I am currently not, nor have I been during the previous three years, a partner or employee of an existing or previous external auditor of the Company or a related company;
- g) I am not an executive member of an elected body in another company in which an executive member of an elected body (i.e., a member of the Board of Directors) of the Company is a non-executive member of an elected body, and I have no other significant relationships with members of the Board of Directors of the Company through participation in other companies or bodies;
- h) I have not sat on an elected body of the Company as a non-executive member for more than twelve years;
- i) I am not a close relative of an executive member of an elected body of the Company, nor of other persons in the positions or capacities set out in a) to h) above.

Of the above points, I do not meet, or the criterion listed above under _____ does not apply to me.⁶
