- Charged on the 481st or 91st or 46th and each additional minute of recharging, or on the 11th and each additional minute from the end of recharging, whichever comes first.
- ** When charging outside Czechia, the equivalent in local currency is applied. For the conversion into local currency, the exchange rate of the European Central Bank valid on the day preceding the transaction is used; the above price (in CZK) is therefore converted into EUR and subsequently (from EUR) into local currency.
- I.1 Calculation and billing is carried out in accordance with the Terms and Conditions of the Charging Service.
- I.2 The above prices are listed incl. VAT
- I.3 The unit price for charging the Electric Vehicle varies depending on the tariff chosen by the Customer. The Customer is entitled to choose the "Basic", "Standard", "Premium" tariff. If the Customer does not choose the "Standard" or "Premium" tariff, the Customer's tariff is the "Basic" tariff (e.g., when registering the Customer). The Customer may select a tariff and change it at any time in the Application or on the Portal; the tariff change shall take place when the Customer confirms the change in the Application or on the Portal.
- I.4 The Customer pays a lump sum payment per month on the Record Date. The Record Date is the day of the month on which the Customer registers or changes the tariff. For example, if the Customer registered on November 14, 2023, the Record Date is the 14th day of the calendar month. In the event that this Customer has made a tariff change as of December 5, 2023, from the moment of the change, the Record Date is the 5th day of the calendar month. If there is no Record Date in a calendar month (e.g., the 29th day of February), the Record Date is the last day of the calendar month.
- 1.5 The Customer shall pay the above flat-rate payment regardless of whether the Electric Vehicle has been charged in the month in question. If the Customer changes the tariff during the month, the Record Date changes and the Customer shall pay the flat-rate payment indicated for the changed (newly selected) tariff.
- I.6 The flat-rate payment is charged for each month and the Provider shall bill the Customer immediately after the selection (change) of the relevant tariff and in the following calendar month always on the Record Date.
- 1.7 The payment card for payment of the price is verified by blocking CZK 300 before each individual charging. This amount is unblocked immediately after the Charging Service price has been billed, but no later than 3 days after the card has been authorized.
- I.8 In this Price List, these terms shall have the following meaning:
 - "≤49 kW": charging from a plug with a stated maximum power of 49 kW or less;
 - "≤ 149 kW": charging from a plug with a stated maximum power of 50 kW or more and 149 kW or less;
 - "≥ 150 kW": charging from a plug with a stated maximum power of 150 kW or more.
